

## DEA National Prescription Drug Take-Back Day October 25, 2025

#### **PURPOSE**

On October 25, 2025, the U.S. Drug Enforcement Agency (DEA) will host the National Prescription Drug Take-Back Day. This is a biannual event hosted nationwide to provide the public with a free and convenient opportunity for the disposal of unwanted, unused, and expired medicines from households. The event is managed by the DEA in partnership with local law enforcement agencies across the United States.

This toolkit is intended to provide clear guidelines and templates to facilitate the promotion and support of the upcoming DEA National Prescription Drug Take-Back Day in conjunction with MyOldMeds.com, and to equip legislators with an overview of messaging and key information in an easy-to-share format.

# PROPER USE, PROPER STORAGE, PROPER DISPOSAL

MyOldMeds.com highlights the importance of proper use, storage, and, when necessary, disposal of unwanted, unused, or expired medicines.



Follow the **instructions exactly as provided**including labeling information and Medication Guides
accompanying the medicine.
If you have any questions, ask your healthcare providers.



In particular, follow any **storage** instructions as provided on the medicine label and on the patient information accompanying the medicine.



Keep the medicine in a **secure** location, either in a medicine cabinet or safely away from people or pets that might come in contact with it.



When medicine is unwanted, unused, or expired, **dispose** of it immediately, properly, and according to local regulations. Remove or destroy all identifying personal information on the medication labels or packaging to protect your privacy.

## Preparing for the DEA's National Prescription Drug Take-Back Day

### October 25, 2025, 10AM-2PM ~

The DEA's National Prescription Drug Take-Back Day is a biannual event hosted nationwide to provide the public with a free and convenient opportunity for the disposal of unwanted, unused, and expired medicines from households. The event is hosted by the DEA in partnership with local law enforcement agencies all across the United States.

If you're planning to participate in the upcoming DEA Take-Back Day on **October 25, 2025 from 10 AM – 2 PM**, keep reading to learn where to go, what to expect, and how to prepare.

### Where does the DEA Take-Back Day take place?

To find an event site near you, use the locator tool featured on the event's homepage <a href="here">here</a>. If you do not immediately find a collection site near you, the DEA encourages visitors to continue checking back frequently, as new sites are added each day. Host locations typically include law enforcement facilities, pharmacies, healthcare facilities, hospitals, and clinics.

## What types of unwanted, unused, or expired medicines will be collected?

During the event, host sites will be collecting pills and capsules. Both prescription and over-the-counter medicines will be accepted.

# **Sample Blog Content**

The DEA cannot accept liquids, sharps, or needles. For guidance on disposal of these types of products, check your local regulations for disposal methods, and then review the following resources provided by the FDA:

- Where and How to Dispose of Unused Medicines
- Best Way to Get Rid of Used Needles and Other Sharps

### What steps should I take to prepare?

- First, collect the unwanted, unused, and expired medicines that you plan to dispose of.
- Next, remove or black-out any personally-identifying information from the products' labels or packaging.
- Keep the products in their prescription bottles or packaging and place them in a clear, sealed bag.
- Finally, be sure to store products you plan to dispose of in a location that is hard-to-reach, out-of-sight, and/ or in a secure storage device (small, personal lock-boxes can be purchased online, or at your local hardware or sporting goods stores), particularly if you have children or pets in your household that may inadvertently come into contact with them.

### What can I expect once I arrive?

Trained volunteers will be available at the event to handle collected materials and ensure safe disposal. You will be expected to provide the materials you wish to dispose of in a clear, sealed bag (volunteers will not be able to accept loose pills or capsules).

When attending the event, be sure to follow any procedures and/or guidance provided by volunteers at your local collection site to help keep yourself and your community safe.

### What if I can't make it to the event?
